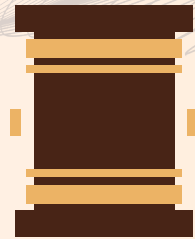

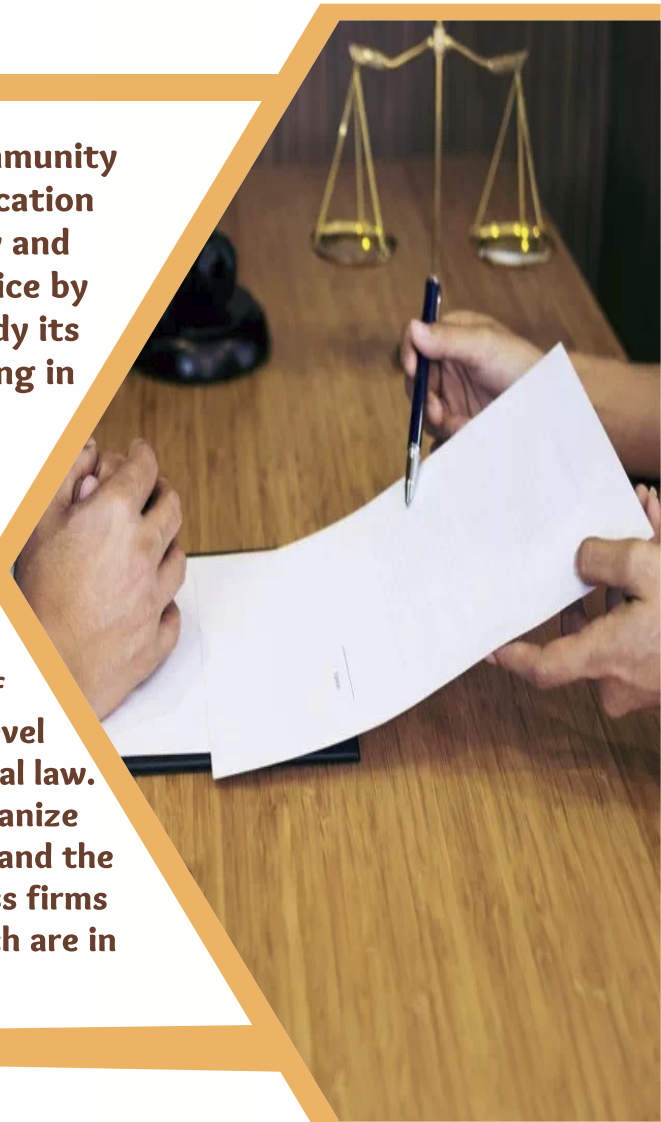


Legal Consultations

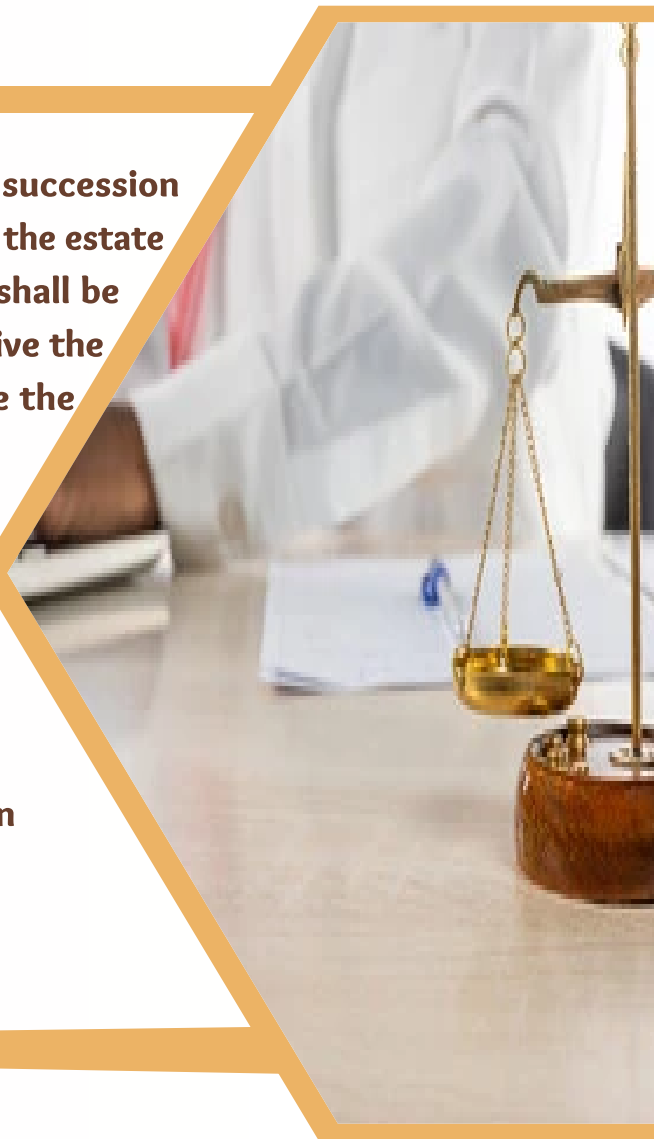


||| Settlement of Estate |
